A Meeting of the Board of Trustees of the Village of Champlain was held on Monday, Dec. 12, 2022 at the Village Office, 11104 Route 9, Champlain, New York.

## MEETING CALLED TO ORDER & ROLL CALL

# REPORT FROM TRUSTEES

# Trustee Herzog

Trustee Herzog reported that he attended the Fire Dept. meeting, & they went over their concerns. They asked for a map of hydrant locations in the Village. Janet stated that she got the map of hydrants from the Supt and sent it to the Fire Dept.

#### Trustee Conner

Trustee Conner reported that the next Game Day will be on Jan. 29<sup>th</sup> from 1-3 p.m. at the Meeting House. All are invited to attend.

# Trustee Molinski

Trustee Molinski reported that 18 children attended the Kid's Crafts and Candy Cane hunt.

Jan. 15<sup>th</sup> at 1 p.m. *Pollination "Bee" Informed* program by a retired beekeeper. This is open to the public. House Decorating Contest judging will take place Dec. 19<sup>th</sup>-21<sup>st</sup>. There will be 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> place winners. Trustee Trombley

The board was provided the Addendum to the Water Board Report.

The EFC authorized the release of the remaining \$30,219.73 left over from the Water Project grant. This amount will be used to reduce the loan payment from \$314,537 to \$284,317.27 due in January 2023. The debt payments for the village and town are \$83,295.29 and \$201,021.98 respectively.

Water Board Recommendations:

- Meter at Wastewater Plant, which will be done with upgrades in 2023.
- Fire District use of water: we wrote to them asking them to let us know about fires.
- Calibrate well and distribution meters: That has not yet been done.
- Water Tank maintenance agreement: that has been completed
- Capital Purchases: agreed with the Town on that.

The board was okay with the report and agreed that Mayor McFetridge could write a letter of acceptance..

# REPORT FROM CLERK/TREASURER MUNOZ

The board has been provided the Expense and Revenue Report for November 2022.

## PRESENTATION OF WARRANT AND PAYMENT

The warrant was presented to the board. Clerk/Treasurer Munoz reported that we are on target except for wages. We paid Woody's sick/vacation time at retirement, hydrant work and vault work is taken out of the water account, and we have an additional employee temporarily. If we need to, we can transfer funds.

A motion was made by Trustee Conner and seconded by Trustee Molinski to approve the warrant with additional invoices of \$900.78 for a total of \$34,946.89. Roll Call vote:

# **NEW BUSINESS**

## 1. Water Rates

Water rates for the Town are currently \$6.25/K gal. We are saving some money on our loan repayment. The Village is saving some money on the O&M because the town has a larger % of EDU's.

Mayor McFetridge had mentioned the idea of decreasing the Town rates by \$.25/K gal which would decrease what we collect by about \$2,700. Discussion followed. Trustee Trombley said that the Town will have to increase their rates by about a \$1/K gal. The Town has to set their rates tomorrow night.

Motion by Trustee Trombley to reduce water rates to the Town by \$25/K gal. No 2<sup>nd</sup> made. No vote taken.

Town rates will remain at \$6.25/K gal.

Amendment to Owner-Engineer Agreement w/ Barton & Loguidice (Water Line Replacement Project) This is an increase of \$1,750 due to DOT requiring soil borings, \$5,000 for funding assistance and \$5,000 for ROW assistance.

Motion by Trustee Conner, seconded by Trustee Molinski to approve Amendment #1 to Owner-Engineer Agreement. All members present voted aye. Motion carried.

## PUBLIC HEARING

At 7:00 p.m., motion by Trustee Molinski, seconded by Trustee Herzog to close the regular meeting.

All members present voted aye. Motion carried.

Motion by Trustee Conner, seconded by Trustee Molinski to open the Public Hearing.

All members present voted aye. Motion carried.

Mayor McFetridge stated that the NYS Uniform Fire Prevention & Building Code is governed by NYS. All municipalities must adopt a local law providing for the Administration & Enforcement of the NYS Uniform Fire Prevention & building code.

No one was present from the public to comment this evening.

Motion by Trustee Conner, seconded by Trustee Molinski to close the Public Hearing.

All members present voted aye. Motion carried.

Motion by Trustee Herzog, seconded by Trustee Molinski to reopen the regular meeting.

All members present voted aye. Motion carried.

# 2. Sewer Credit: Jennifer Shoram

A hose was left on outside which broke and leaked onto the lawn. Supt. Jolicoeur can confirm through observation and pictures that the leak did not enter the wastewater system. The amount of water lost due to the leak was 11,000 gallons.

Motion by Trustee Trombley, seconded by Trustee Conner to approve a wastewater credit of \$52.80 to Jennifer Shoram at 9 Cedar Street. All members present voted aye. Motion carried.

## 3. Local Law #1 of 2022

The local law provides for the administration and enforcement of the NYS Uniform Fire Prevention & Building Code (the Uniform Code) and the State Energy Conservation Construction Code in the Village of Champlain. Motion by Trustee Trombley, seconded by Trustee Conner to approve Local Law providing for the Administration & Enforcement of NYS Uniform Fire Prevention & Building Code. All members present voted aye. Motion carried.

## 4. Robert Wood Grant

We have funds left from the Robert Wood Foundation grant to spend on the Children's garden. Mayor McFetridge suggested a small shed to put near the garden that could be moved.

Motion by Trustee Molinski, seconded by Trustee Conner to approve the purchase of a shed for \$1,200.00.

Discussion followed. Trustee Conner will research sheds with a platform and shelving for supplies.

This matter was tabled until next month.

- NYSEG changed out bad transformer. Blowers had been tripping due to low voltage.
