MEETING CALLED TO ORDER & ROLL CALL

Purchase Requisition

Budget Workshop GENERAL FUND

The new budget includes 3% raises and additional increases due to longevity pay for 2 employees. Law has increased due to several land issues and more code violations. Insurance costs have increased We will be keeping Tina Gardner for another year at \$18,000 under wastewater. The overall increase is \$20,448,41. The matter of a Temp employee came up. Discussion followed. \$2,000 was added to A5110.4, \$800 added to F8340.4 and \$1,200 added to G8130.4 for Temp employee.

Youth Recreation Program

Mayor McFetridge shared information from the Youth Commission meeting regarding program expenses. All expenses (including field maintenance) are to be added together and divided evenly between the 3 municipalities, which would come to around \$6,000 each. We have budgeted this in the past, but that included the swimming program as well. If we add that back in, will be an additional \$4,000 per municipality. Our participation numbers are below those of the Rouses Point and it does not seem fair that we pay the same amount. Discussion followed. Motion by Trustee Conner, seconded by Trustee Herzog to renegotiate the Village costs portion of the Youth Rec. Commission budget. Vote: $\frac{4}{1}$

WATER FUND

We will need an additional \$50,000 for loan repayment for the Water Line Replacement project in the Village. If we increase water rates by \$1.25/K gal and increase service fees by \$10/quarter, we would be able to raise that amount.

SEWER FUND

We have a reserve account for engineering, construction, maintenance of sewer facility.

This amount of \$81,000 would be available to help pay the first \$50,000 loan payment and could be spread out over 2 years so that we don't have to raise rates right away. In order to raise the additional \$50,000 annually, we could raise sewer rates by \$1.25/K gal and increase service fees by \$10/quarter.

Motion by Trustee Trombley, seconded by Trustee Herzog to increase Village water rates from \$5.75/K gal to \$7.00/K gal and increase the service fee from \$27.00/quarter to \$37.00/quarter. Roll call vote:
