### MEETING CALLED TO ORDER & ROLL CALL

#### **NEW BUSINESS**

## 1. Wastewater credit: Richard Gladd at 1 Filion Lane

A service line between the meter pit and their house broke. Supt. Jolicoeur was at the property when they replaced the line and confirmed that water from the break did not enter the wastewater system.

A sewer credit of 23K @ \$4.80/K gal was offered.

Motion by Trustee Conner, seconded by Trustee Trombley to approve the wastewater credit of \$110.40. All members present voted aye. Motion carried.

## 2. Wastewater credit: Valerie Daniels at 28 Locust St.

The tenants at this property vacated in early February and the boiler froze and broke. The sump pump was pumping out of the basement and Supt. Jolicoeur observed that the water from this break did not enter into the wastewater system. A sewer credit of 138K gal @ \$4.80/K gal was offered.

Motion by Trustee Trombley, seconded by Trustee Conner to approve a wastewater credit of \$662.40.

All members present voted aye. Motion carried.

## 3. Village Fest

Village Fest will take place on Saturday, Aug. 13th from noon- 3 p.m.

We will need to order tents, tables and chairs. We will also look into getting a bounce house.

The 5K run will be held in the fall as a separate event.

We typically have EMS, Fire Dept, Sheriff's Dept, State Police and Border Patrol's presence. Other ideas were presented for displays/tables and entertainment.

## 4. Age Friendly Community application through AARP

While working on the Comprehensive plan for the Town and Village, the consultants have suggested that becoming an Age Friendly Community will be good for grant applications. Changes to make a community more livable for seniors include expanded services and local discounts. There is no cost to apply, but it requires a resolution from the board. We will revisit this at our next board meeting.

## 5. Job Posting: WTP and WWTP operator

Woody Kissel will be retiring in the fall. His title is currently MEO (Motor Equipment Operator).

We should label the job correctly as Wastewater Treatment Plant Operator and Water Treatment Plant Operator to attract qualified candidates. We can add other duties to the position as per the Superintendent. A CDL will be necessary. Also, with the new plant upgrades, they will need a higher grade license.

Mayor McFetridge would like to advertise in July and interview in August.

She will send out the 1<sup>st</sup> draft of the job description to the board members for their review.

## 1. Subdivision of Village land

This matter was tabled.

This matter was tabled as we have not yet heard from the Town and we should be following the same rules. Discussion followed.

## 3. Water Tank Maintenance Contract

The Contract is still with our attorney. Mayor McFetridge will follow up.

## 4. Playground Equipment

Supt. Jolicoeur cannot find the instructions for installations. He has reached out to the company but has not heard back yet. Once we have details of the project, we can get some quotes and hire someone from outside to do the installations.
