repaired, but not sure that they are repairable. I have a quote from one supplier for 3 new pumps and am looking for approval for up to \$40,000 for the purchase of 3 new pumps. ### SUPERINTENDENT REPORT: SEPTEMBER 2023

### Water:

- Repaired a failed PRV
- Repaired water main break at Rt. 9/Willow St. intersection
- Completed monthly meter readings
- Raised 2 water shutoffs in the Town that were buried.

### Sewer:.

- Completed sludge drying beds
- Installed new press
- Will need to install a new lift station control panel on Main St/Paquette Blvd.
- Will need to order 2 lift station pumps. Waiting on quotes.

### **Equipment:**

- Will need to have blower repaired for sidewalk machine
- Will need to send the 2010 Peterbilt to the shop for electrical issues
- Will need to install backhoe parts and new tires.
- Will need to send the Kubota in for repairs.
- Will need to fix the gearbox on the lawnmower: it is out of service.

### **Streets:**

- Completed some patch work before asphalt plant closes
- Working on drain repair on Elm Str.
- Installed culverts and drains on Oak St. a& reshaped some ditches.
- Sand was delivered.

### WORK TO BE DONE

- Continue with hydrant repairs.
- Install solar panel on Church St. radar sign and repair Prospect St. radar sign.
- Continue with culvert installation and replacement on Oak St. and Prospect St.
- Continue with sign replacement.
- Lift Station control replacements.
- Bus shelter installation
- Bike path ditching

Brush pickup will begin next week and the last pickup will be on Oct. 31st.

Put loose brush curbside, no bagged debris or leaves will be picked up by the Village.

1 pickup load per property maximum. Make sure brush is cut to size so it can be loaded by hand.

Do not dump anything on Elm St. across from the Library. This dump site was closed a few years ago and is used by Village DPW only for materials.
