#### **NEW BUSINESS**

## 1. Water Theft from Hydrants

A local business needing water for hydro-seeding has been taking water from our hydrants for some time.

This is against Village Code and Town Code. The Town Supervisor is recommending several options:

- 1) Allow the removal of water from the river by individuals who have pumping capabilities. This could be done at the public boat launch. According to DEC this is acceptable with limitations of no more than 100,000 gallons per day, must not cause visible turbidity, and must not cause discharge of pollutant into waterway.
- 2) The Village personnel controls the filling of tanks using the fill line at the Village's wastewater plant. This fill line currently has a back flow device, but does not have a meter. This option would require personnel and would be billed to users. Users would need to make an appointment to get water.

The Board agreed that the second option would work best with the following requirements:

- Must be metered
- Users will be billed
- Village personnel will be required
- There will have to be a minimum charge

Trustee Conner asked about fines for continued use of water at the hydrants.

Trustee Trombley said that the Town is waiting for advice from the court on setting a fine.

The Village Code currently has a fine of up to \$200 for this violation.

Trustee Trombley said that we should wait to hear what the court says and get in line with that advice.

## **OLD BUSINESS**

## 1. Dog Control

The Dog Control Officer has a website link where residents can report any animal issues. This can be accessed from the Town Website and the Village Website.

## 2. DEC Cleanup update

Our current insurance agent contacted the Attorney General's Office. Our current insurance does not cover a past incident, but we did file a claim with the previous insurance company. The Attorney General has our lawyer's contact information and our lawyer is updated on this situation

## 4. Subdivision of Village Property

It was discovered that FEMA buyout land, which includes the property that was to be subdivided, cannot be sold. This was confirmed with Glen Cutter at the Clinton County Planning Dept. Mr. Thibodeau has been informed of this information.
